RoHS and REACH Compliance Declaration

Applicable product(s): All Standard New Age Enclosures

RoHS Compliance

Products made by New Age Enclosures are in compliance with the RoHS Directive (EU Directive 2002/95/EC and subsequent amendments). RoHS compliant means that the substances restricted by the EU Directive 2011/65/EU (**RoHS2**) and EU Directive 2015/863/EU (**RoHS3**) and subsequent amendments of the European Parliament are not contained in a finished product above the threshold limits. EU RoHS specifies maximum levels for the following 10 substances.

Cadmium (Cd): < 100 ppm	Lead (Pb): < 1000 ppm
Mercury (Hg): < 1000 ppm	Hexavalent Chromium (Cr VI): < 1000 ppm
Polybrominated Biphenyls (PBB): < 1000 ppm	Polybrominated Diphenyl Ethers (PDBE): < 1000 ppm
Bis(2-Ethylhexyl) phthalate (DEHP): < 1000 ppm	Benzyl butyl phthalate (BBP): < 1000 ppm
Dibutyl phthalate (DBP): < 1000 ppm	Diisobutyl phthalate (DIBP): < 1000 ppm

REACH Compliance

Registration, Evaluation, Authorization and Restriction of Chemicals (**REACH**) is a European Union regulation dating from December 18, 2006. REACH addresses the production and use of chemical substances, and their potential impacts on both human health and the environment. REACH entered into force on June 1, 2007. REACH Regulation No. 1907/2006 exempts companies established outside the European Union, even if goods are exported into the EU. The responsibility for fulfilling the requirements of REACH lies with EU importers, or with “the only representative of a non-EU manufacturer established in the EU.”

New Age Enclosures is therefore not obligated to register its products; however, to assure our customers that the substances contained in our products are registered and/or pre-registered, New Age Enclosures takes the following actions to achieve REACH compliance:

- We require that all of our suppliers provide a declaration/documentation proving REACH compliance.
- New Age Enclosures will provide all relevant Material Data Sheets (with the substance name, at a minimum) and safe handling practice (if applicable).
- We confirm that the above listed products are made with raw materials that do not contain any of the 240 SVHC's included in the candidate list published on January 23, 2024 as part of their formulation.
